SCRUTINIZER'S REPORT

Dear Sir,

I, Ashish Kumar Jain, Proprietor of M/s A K Jain & Co., Company Secretaries of Mumbai, have been appointed as Scrutinizer by the Board of **Delta Magnets Limited** to conduct the postal ballot of your Company pursuant to Section 110 of the Companies Act, 2013 "the Act" read with Rule 22 of the Companies (Management and Administration) Rules, 2014 for passing of the Special Resolutions proposed in the Postal Ballot Notice dated 04th August, 2014 (hereinafter referred to as '**The Postal Ballot Notice'**).

I submit my report as under.

- I have given my consent to act as Scrutinizer vide letter dated 01st August, 2014 and was appointed as Scrutinizer for Postal Ballot by a Resolution passed at the meeting of the Board of Directors held on 04th August, 2014. Further, at the aforesaid meeting Managing Director and Company Secretary of the Company, were made responsible for conducting the postal ballot process;
- 2. The Company has completed the dispatch of the postal ballot notice and postal ballot form along- with postage pre-paid business reply envelope by registered post and send email on 11th August, 2014 (as applicable) to its members whose names appeared in the Register of Members / Records of Depositories as on 08th August, 2014;
- **3.** The Company has entered into agreement with Central Depository Services (India) Limited (CDSL) the authorized agency to provide e-voting facility to the Members, who were eligible to take part in the voting process.
- The Postal Ballot Forms were kept under safe custody in sealed and tampered proof ballot boxes at the Corporate Office of the Company before commencing the scrutiny of such Postal Ballot Forms.
- 5. The Ballot Box was opened on 11th September, 2014 in my presence.
- 6. Particulars of all the Postal Ballot Forms received upto Wednesday, the 10th September, 2014 till 5.30 pm (being last date of receipt of Postal Ballot Forms) were considered for scrutiny.



- 7. As per Rule 22(3) of the Companies (Management and Administration) Rules, 2014, an advertisement in regard to dispatch of Postal Ballot Notice to the members of the Company, was published by the Company in The Day View in English and Gavkari in Marathi newspapers on 12th August, 2014.
- 8. The particulars of the e-voting done by the members of the Company during the period from 10.00 am on Wednesday, the 13th August, 2014 till 5.30 pm on Wednesday, the 10th September, 2014 by logging on www.evotingindia.com, were considered for scrutiny.
- 9. I have downloaded the e-voting Report from CDSL website by using the scrutinizer's login id and password on Thursday, the 11th September, 2014 at 7.23 p.m.
- **10.** Envelopes containing the Postal Ballot Forms returned undelivered were also not opened and they are kept separately.
- 11. I did not find any defaced or mutilated ballot papers.
